## INVITATION FOR TENDERS

This Invitation for Tenders follows the General Procurement Notice for this project which was published on the EBRD website, Procurement Notices (www.ebrd.com) on 27 April 2011.

Municipal Enterprise of the City of Pskov "Gorvodokanal" (ME of Pskov "Gorvodokanal"), hereinafter referred to as "the Employer", intends using part of the proceeds of a grant from the Northern Dimension Environmental Partnership (the NDEP) towards the cost of renovation of the wastewater treatment plant and development of a SCADA system.

Contract 2. Renovation of WWTP and SCADA system

This contract includes renovation of the Wastewater Treatment Plant and development of a SCADA system for control and monitoring of the renovated plant operation. The renovation of the WWTP will include the design, construction and commissioning of the following WWTP units:

- 1. Screening building with complete machinery;
- 2. Complete repair of primary clarifiers;
- 3. Composting fields;
- 4. SCADA system for control and monitoring of the renovated plant operation
- 5. Chemical phosphorus removal
- 6. Grit removal;
- 7. Aeration system of aeration basin no 1;
- 8. Supply and installation of raw, excess and return sludge pumps with accessories.

The project site is located in the city of Pskov.

Expected time for completion is 540 days.

Tendering for contracts to be financed with the proceeds of a grant from the NDEP is open to firms from the countries which are contributors to the NDEP Support Fund, members of the EU, or countries in which the EBRD operates.

Purchases will be limited to goods and services produces or sold in countries which are contributors to the NDEP Support Fund, members of the EU, or countries in which the EBRD operates.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- the Tenderer shall have an average annual turnover as prime contractor (defined as billing for works in progress and completed) over the last three (3) years of not less than EUR 3 million equivalent;
- the Tenderer shall demonstrate that it has access to, or has available, liquid assets, unencumbered real assets, lines of credit, and other financial means sufficient to meet the construction cash flow for the contract for a period of four (4) months, estimated as not less than EUR 600 000 equivalent, taking into account the applicant's commitments for other contracts;
- the Tenderer shall demonstrate that it has successful experience as prime contractor in the execution of at least three (3) projects of a nature and complexity comparable to the proposed contract within the last five (5) years;
- the Tenderer or its sub-contractor(s) shall have or shall obtain prior to the Contract award all certificates, permits and licences required by the authorities of the Russian Federation related to the scope of this contract (such as construction permits issued by Russian Self-Regulatory Organisations in appropriate sectors or by other authorised organisations);
