This Invitation for Tenders follows the General Procurement Notice 6076-GPN-39459(R1) for this project which was published at 26 February 2010 on the web site of the European Bank for Reconstruction and Development and recently updated on 11 May 2011.

The water supply and waste water services company TVS&V, hereinafter referred to as the Purchaser, intends to use part of the proceeds of a loan from the European Bank for Reconstruction and Development (the Bank) towards the cost of Aktau Water Project.

The Purchaser now invites sealed tenders from Suppliers for the following contract to be funded from part of the proceeds of the loan:

Procurement of Water Meters with radio modules and related services

Related services mean rendering services on carrying out a training course for the Purchaser's personnel on operating and handling the supplied goods.

The estimated completion time under the contract is 3 months.

Tendering for contracts that are to be financed with the proceeds of a loan from the Bank is open to firms from any country.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

(a) the tenderer shall demonstrate experience as Supplier, in at least 3 (three) contracts within the last 5 (five) years that have been successfully and substantially completed and that are similar to the proposed Goods.;

(b) the tenderer shall be able to carry out the repair of the offered goods;

(c) the tenderer shall provide information on any current or past litigation or arbitration resulting from contracts in progress or completed by him over the last 3 years. Tenderers are advised that a consistent history of awards against the tenderer may result in failure of the tender;

(d) the audited balance sheets for the last 3 years shall be submitted and must demonstrate the soundness of the tenderer's financial position, showing long-term profitability. Where necessary, the Purchaser will make inquiries with the tenderer's bankers;

(e) in the case of a tenderer offering to supply goods under the Contract which the tenderer does not manufacture or otherwise produce, the tenderer has been duly authorized by the goods' manufacturer or producer to supply the goods in the Purchaser's country.

Tenders must be delivered to the office at the address below on or before 15:00 (Aktau time) at 25 April 2012, at which time they will be opened in the presence of those tenderers' representatives who choose to attend.
