Under the "China Climate Change Framework Loan" from the European Investment Bank (EIB), Yichang City Project Management Office for Small Hydropower Project (hereinafter referred to as the "Borrower") has applied for an allocation amounting to Euro. 44 000 000,00 from the Ministry of Finance of The People's Republic of China to build Hubei Province Yichang City Small Hydropower Development Project (hereinafter the Project), and the Borrower intends to apply all the proceeds of this loan to eligible payments under the contracts for which these Pre-qualification Documents are issued. China International Tendering Company (abbreviated as "ITC") entrusted by the Borrower as tendering agent now invites interested firms registered in countries eligible to EIB to submit pre-qualification applications for any of the contracts of civil works of Wufeng & Changyang Small Hydro Power Plants.
