1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Water Supply Systems on the Territory of Gurjaani Municipality and in Kvareli and Signagi Service Center Areas for The United Water Supply Company of Georgia (Contract # EIB/WIMP/W/ICB/05).
2. The Municipal Development Fund of Georgia now invites sealed bids from eligible and qualified bidders for works: Rehabilitation of Supply Systems on the Territory of Gurjaani Municipality and in Kvareli and Signagi Service Center Areas.
Lot 1 - Rehabilitation of Water Supply System on the Territory of Gurjaani Municipality. The design stipulates replacement of existing pressure steel pipe d=300-400 mm with new polyethylene pipelines d=355-450 mm, installation of new Chlorinator Plant, replacement of depreciated water piping d=80-150 mm with new polyethylene pipes at 28 streets of Gurjaani and installation of water meters for 2000 users.
Lot 2 - Rehabilitation of Water Supply System in Kvareli Service Center Areas. The Project includes excavation works, laying of 1345.0 m d500 corrugated sewer pipes, laying of 4600.0 m d219x6 steel water pipes, arrangement of 86 wells with d1.0, d1.5, d2.0 collected ferroconcrete, arrangement of locking bars and corresponding molded pieces. Mounting of metal constructions (arrangement of crossovers over the river and ravine).
Lot 3 - Rehabilitation of Water Supply System in Signagi Service Center Area. The project envisages rehabilitation of water mains from Kadiakhi and Karabuga springs, as well as arrangement of sanitary zones at the water sources. Washing and repair works at the Asara No1 and Tsbala No3 boreholes, rehabilitation of Nasamkhrali existing water galleries.
Works for Lot 1 are expected to be implemented from July 2011 to December 2011.
Works for Lot 2 and Lot 3 are expected to be implemented from July 2011 to September 2011.
3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the EIB's Guidelines: Guide to Procurement, February 2004 and is open to all bidders from Eligible Source.

4. Interested eligible bidders may obtain further information from Municipal Development Fund of Georgia, Levan Chichinadze, Executive Director, procurement@mdf.org.ge and inspect the Bidding Documents at the address given below from Monday to Friday 10:00 to 17:00 hours.
5. To be qualified for award the bidder shall meet the following criteria and present the documents to confirm that as a minimum:
 - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: Lot 1 - GEL 6 000 000; Lot 2 - GEL 1 500 000; Lot 3 - GEL 1 800 000.
 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: Lot 1 - GEL 750 000; Lot 2 - GEL 100 000; Lot 3 - GEL 130 000.A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee GEL 300 or equivalent in a convertible currency plus courier expenses if a bidder would like the Bidding documents to be sent by Courier. On request, against a faxed copy of the evidence of the remittance, the Bidding Documents may be sent by courier service if the transport is previously ordered by the Bidder in his country. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person address below at 15:00, June 20, 2011.
All bids must be accompanied by a "Bid Security" (Bank Guarantee) of equivalent for Lot 1 - GEL 70 000 (Seventy Thousand), for Lot 2 - GEL 17 500 (Seventeen Thousand Five Hundred) and for Lot 3 - GEL 21 000 (Twenty One Thousand). A Bid-Securing Declaration is not required.
