Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Marneuli and Tetrtskaro Water Supply Systems for The United Water Supply Company of Georgia (Contract # EIB/WIMP/W/ICB/04).
2. The Municipal Development Fund of Georgia now invites sealed bids from eligible and qualified bidders for works: Rehabilitation of Marneuli and Tetrtskaro Water Supply Systems.
Lot 1 - Rehabilitation of Marneuli Water Supply System. The design stipulates reconstruction of existing water receiver buildings at village Kolagiri of city Marneuli, which includes:
 - Arrangement horizontal water receiver with 23 manhole wells and arrangement pump station "s";
 - Arrangement auxiliary horizontal water receiver with 5 manhole wells and arrangement pump station "b";
 - Building water reservoir, capacity V=600 m3;
 - Arrangement water protecting dam I;
 - Arrangement water guiding dam II;
 - Arrangement fence of sanitation zone.
 - The design stipulates water pipeline reconstruction on Rustaveli street.
 - Change main system pipeline on Rustaveli street;
 - Arrangement regulation wells;
 - Development water pipeline system on Rustaveli street. Supplying consumers with water by small diameter pipes.Lot 2 - Rehabilitation of Tetrtskaro Water Supply System. The design stipulates reconstruction of Tetrtskaro existing water supply system, which includes:
 - Water main from Menqalisi source to inlet pipeline of central reservoir;
 - Water main from Rabbit Farming springs to central reservoir;
 - Rehabilitation of water supply network on G. Brtskinvale, D. Tavdadebuli, Odzelashvili, Garisi, Leselidze, Tbilisi, Samshvilde, Rustaveli, Gorgasali, Tsereteli, Dumbadze, Pushkin, Gamsakhurdia and Barnovi streets;Works for Lot 1 are expected to be implemented from July 2011 to April 2012.
Works for Lot 2 are expected to be implemented from July 2011 to December 2011.
3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the EIB's Guidelines: Guide to Procurement, February 2004 and is open to all bidders from Eligible Source.

4. Interested eligible bidders may obtain further information from Municipal Development Fund of Georgia, Levan Chichinadze, Executive Director, procurement@mdf.org.ge and inspect the Bidding Documents at the address given below from Monday to Friday 10:00 to 17:00 hours.
5. To be qualified for award the bidder shall meet the following criteria and present the documents to confirm that as a minimum:
 - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: Lot 1 - GEL 11.5 mln; Lot 2 -GEL 5.0 mln.
 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: Lot 1 - GEL 1.4 mln.; Lot 2 - GEL 0.6 mln.A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee GEL 300 or equivalent in a convertible currency plus courier expenses if a bidder would like the Bidding documents to be sent by Courier. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person address below at 14:00, June 20, 2011.
All bids must be accompanied by a "Bid Security" (Bank Guarantee) of equivalent for Lot 1 - GEL 115,000 (One Hundred Fifteen Thousand) and for Lot 2 - GEL 50,000 (Fifty Thousand). A Bid-Securing Declaration is not required.
