This Invitation for Tenders follows the General Procurement Notice for this project which was published on the European Bank for Reconstruction and Development's ("EBRD" or the "Bank") website on 27 November 2007, and recently updated on 17 May 2011.

The Municipal Entity City of Pyt-Yakh in cooperation with the European Bank for Reconstruction and Development (hereinafter referred to as "the EBRD" or "the Bank") intends to implement the Pyt-Yakh Municipal Services Development Project. With this view Municipal Unitary Enterprise "Upravleniye Gorodskogo Khoziaistva" (hereinafter referred to as "the Employer") has received a loan from the EBRD.

The scope of tendered works shall include, inter alia, construction of water treatment facilities complex with the designed capacity of 1,500 m3/day with in-site and off-site mains and connection to external utility networks, rehabilitation of two sections of main water pipeline, full scope of design works, supply and installation of plant and materials.

The scope of tendered works is divided into two lots:

Lot 1: Rehabilitation of WTP-1. Stage 2

Lot 2: Rehabilitation of head sections of main water pipelines in District 1

The anticipated time for completion of each lot is 18 months from the Start Date.

Tenders are invited for one or more lots. Each lot must be priced separately. Tenders for more than one lot may offer discounts and such discounts will be considered in the comparison of tenders.

Tendering for contracts is open to firms from all countries. The proceeds of the Bank's loan will not be used for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- (a) Average annual turnover over the last 3 (three) years of at least RUB 72,000,000 for Lot 1 and at least RUB 26,000,000 for Lot 2, or equivalent in a convertible currency.
- (b) Successful experience as prime contractor in implementation of at least two (2) similar projects for construction of water treatment facilities under Lot 1, and construction of water and heat supply pipelines, pressure or gravity-flow sewers of similar diameter under Lot 2. The projects implemented over the last five (5) years shall be of similar complexity as tendered works.
- (c) Access to, or has available liquid assets, unencumbered real assets, lines of credit, and other financial means sufficient to bear costs associated with the execution of the works under the Contract for a period of three (3) months,

estimated as at least RUB 13,800,000 for Lot 1, and at least RUB 5,000,000 for Lot 2, or equivalent in a convertible currency.

- (d) The Tenderer should demonstrate his strong financial position and long term profitability by providing audited balance sheets and profit and loss statements for the last three (3) years.
- (e) For Russian companies: as at the date of Tender submission all taxes due in the Russia Federation shall have been paid.
- (f) Candidate for Tenderer's proposed Site Manager shall have not less than five (5) years total experience, and not less than five (5) years experience of similar work.
- (g) Candidate for Tenderer's proposed Design Manager shall have not less than five (5) years total experience, and three (3) years experience of similar work.
- (h) The Tenderer should demonstrate that litigation and arbitration record of the Tenderer over the last five (5) years does not indicate a consistent history of awards against the Tenderer.
- (i) The Tenderer should have or obtain prior to the Contract award all required permits and certify entry into self-regulating building organisation to obtain permits required for performance of works under the Contract.
- (j) The Tenderer should be certified for quality standard ISO 9001 (or equivalent) or should present his quality assurance plan to demonstrate quality assurance procedures, which shall be applied for the execution of works under the Contract. The lead partner shall meet not less than 60 percent of all the qualifying criteria for general experience and financial position specified above and consortium must satisfy collectively the criteria for personnel and equipment capabilities. Individual members must each satisfy the requirements for audited balance sheets and litigation.

When tendering for more than one lot, the tenderer must provide evidence that it meets or exceeds the sum of all the individual qualification requirements for the lots being tendered for with regard to:

- (a) average annual turnover and access to financial means (sub-paragraphs (a) and (c) above); and
- (b) successful experience (sub-paragraph (b) above).

In case the Tenderer fails to fully meet any of these criteria, it may be qualified only for those lots for which the Tenderer meets the above requirements.
