This Invitation for Tenders follows the General Procurement Notice for this project which was published on the European Bank for Reconstruction and Development's website on July 14, 2006 and updated on 17 June 2009.

Municipal Unitary Utility Enterprise "Vologdagorvodokanal" hereinafter referred to as the Employer has received a loan from the European Bank for Reconstruction and Development (the Bank) towards the cost of the Vologda Municipal Water Supply and Sewerage Service Project.

The Employer now invites tenders for the contract to be funded from part of the proceeds of the loan from the Bank, providing for completion of reconstruction of the Water Treatment Plant.

The Scope of works shall include development of parts of detailed engineering design and working drawings; completion of construction of a new treatment block WTP-4 and completion of reconstruction of the chemicals preparation and dosing facility.

The anticipated time for completion is 12 months from the Commencement Date.

Tendering for contracts to be financed with the proceeds of a loan from the Bank is open to firms from all countries. The proceeds of the Bank's loan will not be used for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations.

To be qualified for the award of a contract, Tenderers must satisfy the following minimum criteria:

(a) The Tenderer shall have an average annual turnover as prime contractor (defined as billing for works in progress and completed) over the last 3 (three) years not less than RUR 500 mln. (Five hundred million) equivalent.

(b) The Tenderer shall demonstrate that it has successful experience in execution of at least 3 (three) contracts of a nature and complexity comparable to the proposed project within the last 5 (five) years.

(c) The Tenderer shall demonstrate that it has access to, or has available, liquid assets unencumbered real assets, lines of credit, and other financial means sufficient to meet the construction cash flow for the contract for a period of 3 (three) months, estimated as not less than RUR 120 mln.

(d) The Tenderer and his sub-contractors shall have or obtain prior to the Contract award all required certificates and permissions provided for by legislation of Russian Federation to perform construction works under the Contract.

(e) The Tenderer shall meet other requirements specified in the Tender Documents.

Tender documents may be obtained from the address below. Contractors wishing to receive the tender documents by courier are required to make a payment of a non-refundable fee in the amount of RUR 13,000, including VAT 18%. The documents will be promptly despatched by courier, but no liability can be accepted for loss or late delivery.
