This Invitation for Tenderers follows the General Procurement Notice for this project ref. 6478-GPN-41847, which was published in the Bank's Procurement Opportunities (www.ebrd.com), published on 9th September 2011.

The Municipal Unitary Enterprise "Lipetsk Aeration Station" (LiSA) intends using the proceeds of a loan from the European Bank for Reconstruction and Development (the Bank) for a project to reconstruct and rehabilitate its Wastewater Treatment Plant. The proposed project, will require the procurement of the following goods, works and services:

- Rehabilitation of three existing aeration tanks
- Rehabilitation of eight existing secondary sedimentation tanks

The Project Implementation Unit ("the PIU") established within LiSA, hereinafter referred to as "the Employer", intends using part of the proceeds of the Bank's loan towards the cost of the Project. The Employer now invites the sealed tenders from contractors for the following contract to be funded from part the proceeds of the loan: Rehabilitation of Aeration and Sedimentation Tanks of WWTP Lipetsk ("The Project"). Works implementation will follow the FIDIC Conditions of Contract for Construction for Building and Engineering Works Designed by the Employer, 1st edition 1999.

Tendering for the Project is open to contractors from any country. The Project is expected to be implemented from October 2012 to August 2016 (incl. a Defects Notification Period of one year), divided into 3 Sections.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- The tenderer must be a firm (a single firm or a joint venture, consortium, or association joint venture, consortium, or association - JVCA) registered as per the national law of their country of registration and accordingly authorised to carry out the Works specified under this contract. In case

of a JVCA this shall apply for all members of the JVCA

- The Annual Turnover (net of taxes and social security charges) of the Tenderer as a whole must be at least 200 million RUB each of the years 2009, 2010 and 2011
- Sufficient liquid working capital for financing the works. The Tenderer, in case of a JVCA the leading member, shall provide evidence of secured financing of not less than 40 million RUB, in form of cash at hand, secured irrevocable credit line granted by a reputable bank or other acceptable form of funds
- The Tenderer, in case of a JVCA the Tenderer as a whole, shall have successfully completed at least two projects of similar nature and complexity as the tendered Works within the last 5 years, where similar nature and complexity is defined as construction and/ or reconstruction of aeration and sedimentation tanks for a municipal WWTP in the amount of min. 200,000 PE and a minimum construction value of 120 million RUB. As successfully completed is defined the issuance of a performance certificate by the Engineer or Employer.

Upon receipt of appropriate evidence of payment of the non-refundable fee, the documents will promptly be dispatched by courier; however, no liability can be accepted for their loss or late delivery. In addition, the documents can be taken by hand at the address as given below after presentation by the prospective tenderer of an appropriate evidence of payment of the non-refundable fee. For ease of preparation of the tenders, part of the documents will also be provided in electronic format. In the event of discrepancy between electronic and hard copies of the documents, the hard copy shall prevail.

The entire tender shall be presented in English and Russian language. All tenders must be accompanied by a tender security of 7,000,000 RUB.

Tender must be delivered to the address below at or before 21 August 2012 at 10:00 Lipetsk time. Electronic tender shall not be permitted. Late tenders will be rejected. Tenders will be opened on 21 August 2012 at 10:10 in the presence of the Tenderers' representatives who choose to attend.
