AD "Vodovod i kanalizacija" Bijeljina, hereinafter referred to as "the Employer", intends using part of the proceeds of a loan from the European Bank for Reconstruction and Development (the Bank) and Municipal Budget towards the cost of Construction of Main Secondary Sewerage Collector No 3 – Majevicka Street.

The Employer now invites sealed tenders from contractors for the following contract to be funded from part of the proceeds of the loan:

Construction of Main Secondary Sewerage Collector MSSC3 – Majevicka Street includes construction of wastewater and rainwater collectors and water supply transmission and distribution pipelines with reconstruction of roads in the scope of the Project. Scope of the Project includes the streets: Majevicka, Mese Selimovica, Brace Gavric, Knez Ivo od Semberije, Roze dr Papo, Tirsova, Vojvode Stepe, Desanke maksimovic, Njegoseva, Kneginje Milice, Svetog Save, Slobodana Jovanovica, Zrtava Jadovnog, Rudjera Boskovica, Cetinjska, Arsenija Cernojevica, Dimitrija Tucovica, Kralja Milutina, Vuka Karadzica, 2 aprila and Trg Djenerala Draze.
