This Invitation for Prequalification follows the General Procurement Notice for this project which was published on the EBRD website, Procurement Notices ([www.ebrd.com](http://www.ebrd.com)) on 13 June 2012.

The Armenian Water and Sewerage Company CJSC intends using the proceeds of loans from the European Bank for Reconstruction and Development [Bank], the European Investment Bank [EIB] and a grant from the European Union Neighbourhood Investment Facility [EU NIF] for a project to rehabilitate municipal water supply networks in 16 towns and villages in several regions of Armenia, as well to improve waste water treatment services in 2 towns.

The Employer intends prequalifying firms and joint ventures to tender for the following contract(s) to be funded from part of the proceeds of the loan:

- Design and construction of the Waste Water Treatment Plants in Dilijan and Jermuk

The services comprise design, supply, installation, commissioning of plant and construction works for:

- Mechanical Waste Water Treatment Plant in Dilijan, app. 22,000 population
- Mechanical Waste Water Treatment Plant in Jermuk, app. 10,000 population

The estimate contract duration will be 12 months design and construction + 12 months Defect Notifications Period.

Prequalification and tendering for contracts to be financed with the proceeds of a loan from the Bank is open to firms and joint ventures of firms from any country.

To be qualified for the award of a contract, applicants must satisfy the requirements regarding experience, personnel, equipment, financial position and litigation history:

- Average construction turnover over the last five (5) years of Euro three million (3,000,000.00) equivalent;

- Successful experience as contractor in execution of at least one (1) contract of nature and complexity comparable to the proposed contract within the last three (3) years;
  - Sound financial position with financial means to meet a construction cash flow of Euro 800,000.00 equivalent for a period of 4 months while taking into account the commitments for other contracts. Long-term profitability must be proven by audited balance sheet for the last five (5) years.
  - The tenderer or its sub-contractor shall hold a valid and effective license/permit for design services, capital construction and for hydro-technical facilities, issued by the RA Urban Development Ministry.
