For procurement of Spreader with capacity 8.800 m³/h for "Field C" of Mining Basin Kolubara under standard EBRD procedure for Supply and Installation of plant.

This Invitation for Tenders follows the General Procurement Notice for this project which was published in 'Procurement Opportunities', 9th May 2011.

Public enterprise "Electric Power Industry of Serbia", Belgrade has received a loan from the European Bank for Reconstruction and Development (the Bank) towards the cost of PE EPS and MB Kolubara Environmental Improvement Project.

The Employer now invites sealed tenders from contractors for the following contract to be funded from part of the proceeds of the loan:

• SPREADER with capacity 8.800 m³/h as a part of the Excavator-Conveyer-Spreader system (ECS), design, procurement of raw materials and equipment, manufacturing, delivery, installation, supervision, testing (individually and as a part of the whole system), training, trial run (of the whole ECS system). The ECS system shall work on "Field C" of Mining Basin Kolubara, estimated duration of contract is 27 months.

The minimum postqualification criteria for all tenderers are as follows:

- The applicant shall have an average turn over (defined as annual earnings) as a contractor over the last three years not less than euro 15 Million equivalent.
- The applicant shall be able to demonstrate the successful experience in the execution of at least one contract of a magnitude comparable to the proposed contract within last ten years. For

assessment purposes, the contractor shall consist of similar contract references of supply and installation of a Spreader with capacity not less than 8.800 m³/h. Subcontractors (if any) for (electrical, ball race, travelling gear, hoisting and slewing gears, hydraulic and lubrication system) equipment with at list 3 deliveries of previously mentioned equipment in last five years.

- Project Manager, Site Manager and Design Manager with minimum 15 years of total experience and 10 years of experience as managers in similar projects.
- The applicant shall demonstrate that it has access to, or has available, liquid assets, unencumbered real assets, lines of credit, and other financial means sufficient to meet the construction cash flow for the contract period of 27 months, estimated as not less than euro 2.5 million equivalent, taking into account the applicant's commitments for other contracts.
- The applicant shall own, or have assured access to (through hire, lease, purchase agreement, availability of manufacturing equipment, or other means), the following key items: auto cranes (min. 2 pieces), basic machining equipment on site (1 carousels, welding equipment), basic installation equipment (min. 3 sets) in full working order, and must demonstrate that, based on known commitments, they will be available for use in the proposed contract.
- The applicant shall provide accurate information on any current or past litigation or arbitration resulting from contracts completed or under execution by him over the last five years.
- The audited Balance sheets for the last 3 (three) years shall be submitted and must demonstrate the soundness of applicant's financial position, showing long term profitability. Where necessary, the Employer will make inquiries with the applicant's bankers.

Tendering for contracts to be financed with the proceeds of a loan from the Bank is open to firms from all countries. The proceeds of the Bank's loan will not be used for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations.
