This invitation for Tenders follows the General Procurement Notice for this project which was published on the EBRD website, Procurement Notices (www.ebrd.com) on 28 February 2011.

The Bodrum Water and Wastewater Administration ('BOSKI' or the 'Employer'), hereinafter referred to as 'the Employer', intends using part of the proceeds of a loan from the European Bank for Reconstruction and Development (the Bank) towards the cost of the construction of the Torba Wastewater Treatment Plant.

The Employer now invites sealed tenders from contractors for the following contract to be funded from part of the proceeds of the loan:

- Construction of the Torba Wastewater Treatment Plant with an average capacity of 2000 m³/day based on biological treatment with nitrogen and phosphorus removal.
- Trenchless rehabilitation of approximately 1100 m of sewer collector made of concrete pipes with diameters between 300 mm and 800 mm diameter.
- The contract consists of complete engineering design and construction, civil, mechanical, electrical, instrumentation, control and automation works necessary for the complete construction of the WWTP, start-up of the plant, 90 day trial operation of WWTP prior to taking over by the Employer, commissioning, operational training of the Employer's personnel during 90 day Trial Operation Period, and hand-over to the Municipality of the complete wastewater treatment plant ready for operation. The contract also covers cleaning by hydro-jetting, camera inspection and trenchless sewer relining of existing sewer collector with polyester material.

Tendering for contracts to be financed with the proceeds of a loan from the Bank is open to firms from any country.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

• The Tenderer shall demonstrate that it has successful experience as a prime contractor in the execution of at least three projects of a nature and complexity comparable to the proposed contract

within the last 5 years;

- Specific experience in at least one (1) contract of wastewater treatment plant, that has been successfully and substantially completed within the last five (5) years (a) with average flow capacity of at least 1,000 m³/day and (b) of which the treatment process is same as the proposed process in this tender.
- The Tenderer shall have an average annual turnover as prime contractor (defined as billing for works in progress and completed) over the last 3 years of not less than EURO 3,000,000 equivalent.
